


State work

The Virginia Department of Rail and Public Transportation (DRPT) is currently in the Federal Railroad Administration (FRA) **Corridor Identification & Development** (CID) process for the Commonwealth Corridor (Norfolk and Newport News to Christiansburg), including **potential station locations**.


• The work is expected to start in early-mid 2026.





Few trips to the Norfolk station (NFK) come from Suffolk.








Identification of Candidate Station Sites- requirements

- Minimum space for train while in station: 1,100'
- Platform length: 725'
- Platform width: 12'
- Minimum siding length: double-ended- 1,600'; dead-end- 1,300'
- Minimum site size: **2 acres**

• 640' available vs. 1,100' required: NG

There is an existing siding along Hall Ave, but building a station along here would require obliterating Hall Ave, therefore this site was rejected.




Saratoga Place


Along the **south side of the mainline tracks**, multiple sidings exist between Lake Kilby and Wellons St, but a station along there would require takings in, or access through, a **neighborhood**, therefore this site was rejected.

Candidate station location


Former CSX Industrial Lead Track (ILT)

- Space for Train while in Station
 - 1,250' available vs. 1,100' required: OK
- Platform Length
 - There is adequate room for a 725' platform: OK
- Siding Length
 - 0.7 mile available vs. 1,300' required: OK

• <u>Site Size</u>

- 2.5 ac. available vs. 2 ac. required: OK
- <u>Note</u>: Being on a rail spur, this location would require trains to back into or out of station, **increasing travel times**.

Norfolk Southern (NS) Spur along Moore Ave



• Space for Train while in Station

• 670' available vs. 1,100' required: NG

• Space for Train while in Station

• 835' available vs. 1,100' required: NG





Golden Peanut Site



• Space for Train while in Station

• 1,125' available vs. 1,100' required: OK

<u>Platform</u>

- Adequate room for a 725' platform; it appears that a 12' platform could be constructed in existing r.o.w.: OK
- <u>Siding Length</u>
 - 1,800' planned vs. 1,300' required: OK
- <u>Site Size</u>
 - 2.1 ac. (parcel 1) vs. 2 ac. required: OK

Due to redevelopment of the site, City staff suggested examining properties **across the tracks**. That analysis follows.



Wellons /Wilson Site

<u>Note</u>: Most (if not all) of these **homes** are occupied.



• Space for Train while in Station

- 1,200' available vs. 1,100' required: OK
- Platform Length
 - There is adequate room for a 725' platform: OK

- Siding Length
 - 2,100' planned vs. 1,600' required: OK
- <u>Site Size</u>
 - 3.1 ac. available (parcels 1 thru G) vs.
 2 ac. required: OK



Main/Commerce





<u>Note</u>: City staff indicated a willingness to close **Commerce St** at the tracks.

- Space for Train while in Station
 - 1,175' available vs. 1,100' required: OK
- Platform
 - Adequate room for a 725' platform: OK
- Siding Length
 - 1,600' planned vs. 1,600' required: OK
- <u>Site Size</u>
 - Compiling city-owned parking lot with parcels between it and the railroad track would provide a total of 2.2 acres, greater than the 2 acre requirement: OK
